Kauwila agrees to provide the following:

Transportation to and from the performance location.

All musical instruments needed.

All necessary sound equipment, including mixers, amplifiers, etc.

Note: if Kauwila and client judge that venue requires larger sound system, client will provide.

Arrival at location approx. one-hour prior to performance (unless unforeseen circumstances prevent).

A continuous performance, with one 10-15 minute break per hour (for 1 hr., 0 breaks; 2 hrs., 1 break; 3 hrs., 2 breaks; 4 hrs., 3 breaks).

A joyful, uplifting performance!

Client agrees to provide the following:

FOR ALL EVENTS

Sufficient space at location for musical equipment and sound system.

Electrical outlet (110V AC) and extension cord if outlet is more than 8 feet from performance space.

For structured events (with speakers, etc.), a schedule so Kauwila knows what to expect.

For events where meal is served, FOOD for the entertainer.

If appropriate for the venue, a rest station.

Permission for Kauwila to sell his CDs.

Location where Kauwila may sell his CDs (usually next to the performance area).

NO BACKGROUND MUSIC OR OTHER INTERFERING MUSIC WHICH CAN BE HEARD IN THE PERFORMANCE AREA AT ANY TIME DURING KAUWILA'S PERFORMANCE.

Payment of remainder of fee at the conclusion of the performance (or any time prior).

If rain is expected or probable, protection from rain (for Kauwila and equipment), minimum 8' x 8' (e.g., waterproof canopy, or large (> 10 ft. diameter) waterproof umbrella).

FOR DAYTIME (pre-sunset) PERFORMANCES:

Shade from sun, minimum 8' x 8' (e.g., canopy , or large (> 10 ft. diameter) umbrella).

A fan (for warm locations without prevailing breezes).

FOR NIGHTTIME (post-sunset) PERFORMANCES:

Lighting for performance space so Kauwila can see all equipment and instruments.

A fan (for locations where mosquitoes are to be expected).

Payment Agreement

DEPOSIT of 50% of total fee is to be paid upon signing this contract. Deposit will be refunded if cancellation notice is given at least 10 DAYS prior to event date.

REMAINDER OF FEE IS PAYABLE IMMEDIATELY UPON COMPLETION OF PERFORMANCE (or at any time prior), by cash or check (payable to "Let Your Joy Shine Productions").

Fee charged is for the time period designated on page 1.

If Kauwila were unable to perform (due to emergency), deposit would be refunded.
